### **Rome Police Department Monthly Report**

May 2023

#### **Meetings/Training Attended**

During the month of May, I attended an Adams County Traffic Safety meeting. Officers Jenks and Jasin attended applicant background investigations training. Officers attended a legal update/search warrant training with the City of Adams PD. The District Attorney and Adams County Judges presented the training.

#### Calls for Service, Citations, and Written Warnings

During the month of May, officers handled 164 calls for service, issued 73 citations and 29 written warnings.

#### **Department Activities/Announcements**

Boat patrol staff is in place for the 2023 boat patrol season. We have four officers on the roster for the 2023 boating season. The officers will work Friday thru Sunday as the weather warrants for boating enforcement on our local lakes.

The Boat Patrol logged 38 hours of patrol in May, issuing 7 citations and 2 warnings for various boating law violations. Boaters, please take the time to read the current boating law handbook prior to hitting the water this summer. Please follow all the rules to have a safe and enjoyable boating season. Motorboat operation is restricted to Slow-No-Wake after 8pm thru sunrise. No personal watercraft shall be operated at a speed greater than slow-no-wake before 10:00 a.m. or after 8:00 p.m. Water skiing, wake surfing or being towed on other devices, shall be limited to the daylight hours between 10:00 a.m. and 8:00 p.m. or sunset whichever comes first. The regulations are in place to ensure everyone's safety on our lakes. If you see individuals violating the rules, or operating in an unsafe manner, please report it immediately by calling 877-885-9977 option 0.

I would like to inform residents, it is that time of year again when the Rome Police Department starts to receive complaints on fireworks. The police department will have a zero tolerance for illegal discharge of fireworks. A commonly used rule of thumb is that if the device explodes or leaves the ground it is unlawful to discharge without a permit. The permits issued at many roadside stands indicate a specific place for the discharge of the fireworks. NONE of those are in the Town of Rome, so any discharge would be illegal and subject to a \$250.00 fine and confiscation of the fireworks.

The 2022 Ford F150 upfit was completed and the vehicle is in service. Routine maintenance was done to the fleet in May.
